AISA's exciting new Foundation Scholarship Fund is open to applications from individuals who are Australian citizens and meet any of the following:

- 1. identify as women;
- 2. ordinarily reside in a rural or regional area of Australia;
- 3. are financially disadvantaged or are experiencing financial distress;
- 4. identify as Aboriginal and/or Torres Strait Islander Australians

A new AISA Foundation Scholarship Fund Committee has been established to provide oversight and governance of the Fund. AISA welcomes to the committee Narelle Devine, Tom Crampton, Gai Brodtmann, Joshua Craig, Suelette Dreyfus, Patrick Fair, John O'Driscoll, Greg Adamson and Damien Manuel.

The role of this committee will be to approve eligible candidates applying for scholarships and disperse the funds necessary.
